



# Good News, Good Advice and Good Food at Annual Stockholders Meeting

The stockholders of Mississippi Land Bank gathered together on April 11 in Como to hear about the association's success.

Chairman Abbott Myers spoke to the association's members about the local agriculture economy, and discussed the current down cycle in agriculture. He said the best advice he was given came from his father, who told him, "If you make a good crop, save some of that money — you'll need it when things aren't good."

Myers also stated he was especially pleased to promote the cash patronage payment that was paid out in the amount of \$2.9 million. He reminded the stockholders that when Mississippi Land Bank declares patronage, every bit is paid out in cash to the stockholders at that time, not over a period of several years.

Craig Shideler, president and CEO, reviewed the year-end financial results, which were highlighted by growth in loans and earnings.

The president's speech was followed by director


The meeting concluded with a steak luncheon.


